- e. 'Committee' volunteers who arrange, organise, promote, and manage the event.

- h. 'Photographer' means photographer and/or videographer.

## **Explanation**

- a. The Prayer Breakfast is an annual event held at the Albury Entertainment Centre or similar venue, with people primarily from across Albury and Wodonga regions attending. This can include men and women from churches, State and Federal parliamentarians, heads of churches, leaders in local government, senior public servants, local Councillors, local business people and community leaders.
- b. The program for the breakfast includes:
  - i. A key-note speech by a recognised public figure who has made a significant professional and leadership contribution in their sphere of influence. They will be sharing something of the story of their lives, upbringing, and experiences and the impact faith has had on their life and leadership.
    - ii. prayers will be delivered by a representative cross-section of attendees.
    - iii. musical items by local schools and artists.
    - iv. breakfast and refreshments.

## **Tickets and Registration**

- a. The fees in respect of tickets and registration to the event will be specified on our website.
- b. Tickets are sold in units of singles (individual seats) and tables (seating for 10 people).
- c. Tickets will be available for a discounted price up to and including the advertised early bird cut-off date on our website. After the cut-off date, tickets will revert to the standard rate and will be available until the final date of sale as advertised on our website.
- d. We reserve the right to change our ticket prices at any time.
- e. Tickets to the event must be registered and paid for in full and in advance before the advertised final date of sale.
- f. An invoice/receipt will be issued automatically by email at the time of registration and purchase. If you do not receive an invoice/receipt, contact the office for a copy.
- g. We are not registered for GST and there is no GST included in the ticket prices.



- h. Ticket registration and purchase apply to the advertised year of the breakfast and may not be transferred or used for future Prayer Breakfasts.
- i. Information is collected from those registering in order to facilitate ticket purchases or other services available. This information is collected and used in accordance with our Privacy Policy, which forms part of these conditions.

# **Limits Of Our Liability**

- a. The Albury Wodonga Prayer Breakfast does not accept any liability for non-completion of the event or for any delays arising as a result of strikes, riots or lockouts, adverse weather conditions, loss, damage or cancellation due to fire, flood or any other cause beyond its control.
- b. In the case of non-completion of the event, any refund of the ticket purchases will be considered and determined upon the costs incurred and the nature of the cancellation.
